*Any person who knowingly and wilfully makes a false statement or declaration in connection with an application for registration as a voter or any other statement or declaration for the purpose of the Electoral Decree 2014 commits an offence and shall be liable upon conviction to a fine not exceeding \$50,000 or to a term of imprisonment not exceeding 10 years, or to both.*
